## **Methodological note**

The objective is to promote an exercise which helps us to read the real situation and to reflect on our faithfulness to our proper identity in our own country, so that then a synthesis may be sent to us, so that we may be able to compile the necessary data which will be sent in our second communication and which will provide the preparatory material.

- 1. The material is sent to CA's national or diocesan leaders, IFCA's members, and to the observers.
- Both leaders and assistants are requested to involve themselves in preparing the requested contribution: at national/diocesan/parish level.
- Every country is requested to send a synthesis through the tables in order to enable the secretariat to draw up the final programme of the Third Assembly.
- 4. Every country is also requested to send as much material as possible, which can be useful.
- DOCUMENTS of BUENOS AIRES: only now we are able to send the DOCUMENTS: we feel sure that they will be utilized to prepare the Assembly as they can actually be a contribution for the reflection of our associations.

## Introduction

We have started the year of the Great Jubilee of the Incarnation.

The Jubilee is a special call for interior reconciliation. It is a call to conversion, on a personal basis, as an association, as a Church. It is a deep review of our life, of our behaviour in view of what the Lord is expecting of us, so that this authentic discernment may lead us to a greater commitment.

In this context we are going to celebrate our Third IFCA general ordinary Assembly, from the 2nd to the 6th December, with the theme:

The lasting actuality of a gift of the Holy Spirit

Catholic Action: lay faithful who live the ever newness of the Gospel

and are a sign of communion.

It is important therefore to work out together preparatory guide-lines to this Assembly, which will help us to review, with the utmost sincerity, our faithfulness to this gift received from the Holy Spirit, and our faithfulness to the conciliar identity of Catholic Action and to the present historical situation.

We propose the all Catholic Action members reflect on these points together, helped by the extraordinary blessings of the Great Jubilee.

"The Holy Door of the Jubilee of the Year 2000 should be symbolically wider that those of previous Jubilees, because humanity, upon reaching this goal, will leave behind not just a century but a millennium. It is fitting that the Church should make

this passage with a clear awareness of what has happened to her during the last ten centuries. She cannot cross the threshold of the new millennium without encouraging her children to purify themselves, through repentance, of past errors and instances of infidelity, inconsistency, and slowless to act. Acknowledging the weakness of the past is an act of honesty and courage which helsp us to strenghten our faith, which alerts us to face today's temptations and challenges and prepares us to face them" (TMA 33).

The Assembly takes place at 35 days after the the Ecumenical Vatican Council II (December 8th 1965) and aims to become a privileged moment of examination in the jubilar spirit, according to John Paul II's directions, of renewal in the light of the Council and of purification from a path of "infidelity, inconsistency, slowless" during these years, also as CA.

Starting from John Paul II's consideration, that "the Second Vatican Council was a providential event, whereby the Church began the more immediate preparation for the jubilee of the Second Millennium" (TMA 18).

This is IFCA Third ordinary Assembly and requires therefore a reflection on the very identity of our organism as well as a specific review of the commitments assumed by all of us together as well as by every association during the Second Assembly in Buenos Aires in 1997 - the relevant DOCUMENTS are available.

The Third Assembly opens the new millennium and demands from us an extra commitment to look at the three following years which are inserted in a vast context, both retrospective (see 1) and in perspective: to prepare this meeting an "exceptional" time of prayer and work is needed, which may enable us to look at IFCA's future with trust, with hope, with courage and with joy.

Let us beg the Lord, through the intercession of so many saints, blessed and friends in the communion of the saints, to grant us a great heart, an open intelligence, love for the humanity and the history of our time, in order to participate in the life of the Church, to be Church, with that peculiar form of ministeriality which qualifies us and by which we were inspired in working out the theme of this "jubilar" assembly, on the threshold of the third millennium: The lasting actuality of a gift of the Holy Spirit. A im: reading the signs of the times.

Preparation is necessary to enable us to see the true situation. In order to achieve this we should ask our Lord to give us a clear vision and an unprejudiced heart, so that we may be able to understand the real situation, to look at the world discovering the hidden seeds of the Word at the beginning of this millennium.

We suggest that this exercise be worked in groups, focusing on an analysis of the real situation in the world, in the country, in the community, in the universal and in the particular Church so that christian values and worldly values, lights and shades, positive and negative aspects, opportunities and difficulties may be identified.

#### STARTING POINT

The lecture by V. Espeche GIL at the Second Assembly of Buenos Aires, with the theme "The world we live in", subdivided into the following chapters:

1. The issue of globalization. 2. The issue of validity of values in the contemporary culture. 3. The world in which we want to live.

As a result of this exercise we expect a synthesis including three positive and three negative aspects which are to be noted in the table which follows.

If the work is carried out in different groups, a final version which is arrived at by common consensus and which is the country's final contribution, is to be sent to the secretariat, together with the exercised proposed in the second part, within JUNE 30th 2000.

## Part II - Reflection on how we live our identity

The Holy Spirit has donated Catholic Action, with a specific identity, as a gift to the Church.

Catholic Action's identity is defined in the conciliar ecclesiology of communion and mission, in the 4 foundamental notes: it is ecclesial, lay, organic, and collaborates with the Hierarchy (cf AA 20). The four notes gathers the richness of tradition and experience of all preconciliar Catholic Action.

The birth of the many lay movements after the Council has given a new impetus to the Church and has led to a great richness in the variety of charisms bestowed by the Holy Spirit.

The Synod on laypeople, whose recommandations are found in the apostolic exhortation on laypeople's role in the Church and in the world, was held in this context. In this document John Paul II explains clearly these conciliar teachings and among all the ecclesial movements places Catholic Action as that association called to work, with loyalty and fatigue, for the enlargement of the whole christian community, the pastoral plans, the evangelic animation of all spheres of life (CFL 31).

It is in the light of our identity that we initiate this reflections so that we may review our faithfulness to the gift we have received, so that we may be able to turn to the Lord and express more precisely our answer as a Catholic Action which is faithful to its conciliar identity and to the present historical situation.

We suggest that this exercise should first of all be carried out individually and then shared in study-groups.

We recommend to start with the reading of I Cor 12,4-11, where Saint Paul expresses clearly that there is a diversity of gifts but the one Spirit and that every manifestation of the Spirit is for the common good.

#### STARTING POINT

The lecture by H.E. Mons. Stanislaw RYLKO, Secretary of the Pontifical Council for the Laity, at the Second Assembly in Buenos Aires, with the theme:

"The Church and the world: dialogue and path of salvation.

CA LAY PEOPLE FROM THE SECOND VATICAN COUNCIL towards the third millennium", subdivided into the following chapters:

- 1. Living the mystery of the Church
- 2. Understanding the reality of the world
- 3. A Church in solidarity with the world
- 4. The dialogue of salvation
- 5. "It is time for action..."

# Questions to help to the reflection

- 1. Is Catholic Action looked upon by its members and regarded by the community as a gift of the Holy Spirit?
- 2. How does Catholic Action take upon itself this reality which characterizes it internally?
  Which are the opportunities? Which are the difficulties?
- 3. How does Catholic Action participate in the Church's mission?

How is the priority to that which is spiritual expressed?

How does it participate concretely in pastorale care, in the new evangelization, in the mission ad gentes?

Do Catholic Action members live the good news of the Gospel in the world? How is the evangelic animation of the various spheres of life shown concretely?

4. Does the organic set up of Catholic Action, its organization and its structure help in building relations among people of different ages and different life conditions?

Is there any risk to let ourselves be conditioned by the structure so that the organization makes it difficult for us to act?

How is Catholic Action present and what is its relation as an organization in the life of the Church and in social life?

5. How is the collaboration with the Hierarchy carried out concretely?

What kind of dialogue exists with the Pastors?

In what way does Catholic Action participate in the working out and carrying out of pastoral plans?

In what way do Eccleiastic Assistants contribute towards the life of the association?

6. Is Catholic Action a sign of communion?

How is this shown concretely?

Does the community look upon it as a contributor towards the promotion of communion?

What is its relation with the other lay movements and associations?

7. Does Catholic Action provide a formation programme for the different age groups?

Wha is Catholic Action doing to create an awareness towards the lay vocation and towards the commitment to build a world according to evangelic values?

How it is contributing towards the missionary formation of laypeople?

8. In the contexts where the Church has undergone martyrdom and now - in "freedom" - must face secularization and crisis of Christianism, how does CA witness the faith without yielding to the culture of consumism, individualism, relativism and how does it help the Church to live in the world "without being of the world"?

At the end of this reflection, we express our thanks to the Spirit for the gift we have received, and ask for strength for a change of heart and to accomplish our mission more faithfully. We also express our commitments, note them in the table which follows and send them to IFCA's Secretariat within JUNE 30th 2000.
